Qualifications and eligibility:

1. A pass in 2 years intermediate in MPC stream and Qualified in AP EAMCET-2017.
2. The candidate should have completed 17 years of age as on 31st December 2017 and upper age limit is 22 years (25 years in case of SC & ST candidates).

The criteria of selection is based on EAMCET ranking.
