In the reference 1st cited, the University has issued guidelines with regard to procedure to be followed for engaging Contract Teaching Faculty utilizing the service of eligible candidates in Colleges / Research Stations / Polytechnics etc on payment of fixed remuneration for a period not exceeding 175 days.

As per the permission issued by the University through the reference 2nd to 5th cited, 05 posts have not been filled up. In the reference 6th & 7th cited permission has been accorded to engage to Contract Teaching faculties to the CVSc, Tirupati duly following the guidelines issued by the University for a period not exceeding of 175 days from the date of joining (or) till the posts are filled on regular basis whichever is earlier.

In the reference 8th cited a committee has been constituted and advertisement has been issued vide reference 8th cited for the above purpose and interviews were held on 21.03.2018 and the committee has issued recommendations vide reference 9th cited.

In the view of the above recommendations, Permission is hereby accorded to the following HODs to utilize the services of the following MVSc & BVSc Candidates as Contract Teaching Faculty against the Vacant posts noted against them for a period of 175 days with effect from the date of engaging on payment of remuneration for Ph.D holders Rs.37000/-, MVSc holders Rs.35,000/- and BVSc & AH holders Rs.23,000/- PM each as detailed below:
