PROCEDURE FOR BID SUBMISSION ON e-PROCUREMENT PLATFORM:

1. The bidder shall submit his response through Bid submission to the tender one-Procurement platform at **“www.apeprocurement.gov.in”** by following the procedure given below. The bidder would be required to register on the e-procurement marketplace **www.apeprocurement.gov.in** (or) **<https://tender.apeprocurement.gov.in>** and submit their bids online. Offline bids shall not be entertained by the Tender Inviting Authority for the tenders published in e-procurement platform.
2. The bidders shall submit their eligibility and qualification details, Technical bid, Financial bid etc., in the online standard formats displayed in e-Procurement website. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria/technical bids and other certificate/documents in the e-Procurement web site. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity. The bidder shall attach all the required documents for the specific tender after uploading the same during the bid submission as per the tender notice and bid document.

4. **Hardcopies:**
 - i) Attested copies of all original hard copies of the uploaded scanned copies of D.D/ towards EMD by participating bidders must submit along with sample of the product/commodity to the tender inviting authority before scheduled date and time of the opening of the Technical bid, otherwise the tender will be rejected on online.
 - ii) All the bidders shall invariably upload the scanned copies of DD/in e-Procurement system and this will be the primary requirement to consider the bid responsive.

TENDER TERMS AND CONDITIONS

1. Online (e-Tendering) tenders are invited for procurement of Feed ingredients to prepare approximately 1,500 tonnes of compound feed in six months to **TTD-Feed Plant operated by SVVU, Tirupati**. The compound feed majorly shall comprise approximately 40% energy sources (grains), 25% protein sources (Oil cakes), 25% cereal by-products (Brans), Upto 10% molasses, 1% Urea and 1-2% Trace minerals and Vitamins.

Note: The feed ingredients shall be purchased depending upon the feed formulation and availability of stocks, price variations and seasonal variations, which will be indented in supply order.

The College desires to have this tender in two bids i.e., (1) Technical bid and (2) Financial bid and also desirous to procure the same from more than one tenderer, if needed. The tenderer should have been in this trade for not less than one year during the last three years and should have supplied bulk quantities to any reputed institution or institutions as the case may be. A copy of the certificate issued by the authorities under Shops and Establishments Act and a copy of the supply/purchase order for having supplied bulk quantities, have to be scanned and uploaded for technical bid evaluation by the College. The interested tenderers are also required to submit the 1 KG samples for each of the feed ingredients with seal neatly packed. The sample for HDPE/PP WOVEN bags (50kgs,) should also be submitted to the Tender Inviting Authority. All Tenderers should submit the attested copies of all scanned and uploaded certificates online including ORIGINAL DEMAND DRAFT towards EMD to the Tender Inviting Authority on or before scheduled date and time of opening of the Technical bid as mentioned in NIT. In the process of technical bid, the samples submitted by the tenderers will be verified physically and also by Lab Testing. The decision of competent authority is final and binding on the Tenderers without any recourse. The financial bids of those tenderers who are technically qualified and who prequalify in sample testing, will be opened on the date and time as mentioned in the NIT by the Associate Dean, College of Veterinary Science, Tirupati or any other officer authorized by him. 2. Only one variety of each item shall be quoted in the Tender and the **1 KG samples for each of the feed ingredients with seal and the sample for HDPE/PP Woven bags (50kgs,)** should be sent duly signed along with the attested copies of the scanned and uploaded certificates with ORIGINAL DEMAND DRAFT towards EMD to the Tender Opening Authority on or before scheduled date and time of opening of the Technical bid which will be opened on the date and time as mentioned in the NIT, failing which the tender will be rejected.
3. EMD amounts as mentioned in NIT against each item in the Sl. No 10 is to be remitted as Earnest Money Deposit by way of an Account Payee Demand Draft drawn in favour of the Associate Dean, College of Veterinary Science, Tirupati, payable at Tirupati on any scheduled bank and should scan and upload at the time of tendering. Security Deposit @2.5% will be deducted in each and every supply bill. The EMD and Security Deposits will be released only after successful completion of the supply in all respects. 4. The rate quoted should be valid for acceptance for a period of ninety days (90days) from the date of opening.
