WALK -IN -INTERVIEW

Interested candidates can appear for a Walk-in-Interview for the position of Young Professional-I (**YP-I**) (**One position only**) in the “*BMGF Collaborative Project on PoC for Ruminants expressing ligninase to reduce carbon footprints*” **at 02:30 PM on 17th December 2024** (Tuesday) at Office of the Associate Dean of the NTR College of Veterinary Science with filled-in Application form as provided in Annexure 1 and xerox copies of academic qualifications, experience certificate of working in any other project elsewhere (if any), social status certificate (if any) etc. along with original certificates. The Young Professional-I (**YP-I**) position *is purely temporary, likely to be continued till July 2027 only and the position is co-terminus with the project.*

Essential Qualifications:

Bachelor's Degree in any streams of Life Sciences including Agriculture & Allied Sciences, Biotechnology/Biological Sciences.

Desirable Qualifications:

- Post Graduation & above in any stream of Life Sciences including Agriculture & Allied Sciences, Biotechnology/Biological Sciences.
- Experience of working as JRF/SRF/YP etc. in any other Life Sciences related projects
- Conversant with routinely used computer applications in office/lab.

The minimum age limit for the Young Professional I (**YP-I**) position is 21 years and maximum age limit is 45 years as on date of interview, as per ICAR guidelines. Total consolidated emoluments per month as per ICAR Norms is **Rs. 30,000/- per Month (Fixed)**. The selected YP-I shall have to take up any work related to the project assigned by the Principal Investigator. Continuation of selected YP-I during tenure of the project is based on the periodical performance appraisal. The Candidates are advised to look into General terms and conditions of engagement mentioned below. The applicants should bring along with them Five Sets of filled-in application as per format attached in Annexure 1 of this notification.

General terms and conditions

1. Engagement of Young Professional I is purely time bound, non-regular and not against any sanctioned vacancy/ cadre strength/ post/ position of the College/University.
2. If the candidates are large in number, shortlisting will be done based on their qualifying academic performance as per the assessment criteria/written examination and only the shortlisted candidates will undergo a panel interview.
3. The candidate must bring 5 copies of application form annexed in Annexure-I.
4. Upon completion of project, the Engagement shall automatically terminate without warranting any notice on the part of the Project Investigators or the Institution. Unsatisfactory performance of the YP-I may lead to termination of engagement at the discretion of Competent Authority at any time.
5. The candidate must bring his/her original copies as well as one self-attested copy of all certificates mentioned in Annexure 2 including experience certificate, at the time of interview, failing which the candidate will not be allowed to appear for the interview.
6. No TA/DA will be paid for attending the interview.
7. Persons already engaged in any other project should submit “No Objection Certificate” from their current Project Investigator and there should be a clear mention of stage of that current project. In case the candidate is selected for this project, he/she should inform likely date of joining which should preferably be within 5 working days.
8. For leaving the engagement as YP-I in between the stipulated period, he/she shall have to give a minimum of two months notice in advance, to avoid disturbance of the Project/Office work.
