Applications are called for from the eligible teaching faculty in SVVU, Tirupati for award of promotions under Career Advancement Scheme under UGC Regulations 2010 and 2018 with cutoff dates **30.06.22**, **31.12.22**, **30.06.23**, **31.12.23** and **30.06.24**.

Further, in order to avoid any hardship, the candidates who fulfill all other criteria mentioned in the CAS 2018 Regulations notified on 18-7-2018, can be considered for promotion from the date, on or after the date, on which they fulfill these eligibility conditions. Those faculty members who have already qualified or are likely to be qualified shortly under the CAS 2011 Regulations, a choice is given to them for being considered for promotions under the existing CAS 2011 Regulations.

The applications should be accompanied by score cards i.e. Tables 1 for Level 11 and 12, Table 1 and 2 for level 13A and Level 14, Table 3 for Assistant Professors of Library Science and Associate Professor of Library Science and Table 4 for Assistant Professors of Physical Education and sports and Associate Professors of Physical Education and Sports.

The candidate should go through the application form thoroughly and carefully before filling the details.

- 1. The application form along with enclosures and self assessed score cards should be submitted in five (05) sets in case of level 11 and 12 and (06) sets in case of level 13 A, 14 & 15.
- 2. Those claiming promotion under CAS 2011 Regulations have to apply as per application format and PBAS formats of CAS 2011 Regulations. 05 Sets for Stage.II & III, 06 Sets for Stage.IV, V & VI
- 3. All the enclosures/proof of claims should be enclosed to the application form serially numbered at the bottom of the page with black ballpoint pen.
- 4. The candidate claiming marks under each sub head has to enclose the relevant documents as proof of claim. The proof should be assigned a proper number

- 5. The application form along with enclosures should be spiral bound with A4 size only
- 6. Application form without enclosures or enclosures submitted in absurd manner or without serial numbers will not be entertained and are liable for rejection.

All the applications under CAS 2018 Regulations will be considered as per the further guidelines issued vide reference (4) cited.

The application formats and score cards of both CAS 2018 and CAS 2011 Regulations can be downloaded from the SVVU website i.e. **www.svvu.edu.in**.

Those who get promoted as Associate Professor and Professor under CAS will be transferred and posted in a place other than present campus.

All the Heads of Institutions are requested to certify the service particulars and details of leave availed, by the candidates by verifying the same with their Service Registers and certify the correctness of the particulars furnished in the application. Further, it has to be indicated clearly whether any leave i.e. Earned Leave / HPL / EOL (without pay & allowances) is availed, if not "Nil" has to be indicated. The Heads of Offices will be held responsible for any wrong information furnished by the applicants. The applications shall be forwarded with their endorsement to "The Registrar, Sri Venkateswara Veterinary University, Administrative Office, Dr YSR Bhavan, Tirupati-517502".

The intending teachers are directed to submit their applications on or before 21.09.2024 to the University. The applications received after due date will not be considered.
