
Dear Sir/Madam,

It is to inform that for the Academic year 2020-21, the **15% seats under All India VCI Quota** for **B.V.Sc. & A.H degree** programme in the recognized Veterinary Colleges will be filled up by the Veterinary Council of India New Delhi. The process will start from **30-12-2020 (Wednesday)** through **Online counseling** and the merit list of Common Entrance Examination-National Eligibility-cum-Entrance Test (**NEET-UG**)-2020 conducted by NTA will be used for the purpose. The Authorities of the Veterinary Colleges/Universities are requested to kindly note in this regard and give wide publicity and also facilitate for admission/reporting of the candidates to the respective colleges. The colleges are requested to inform the VCI, New Delhi about the details of admissions done in each round of Counseling in a time bound manner so that, the list of vacant seats after each round of counseling will be uploaded and allotted, accordingly.
