- Hence, the qualified candidates who could not get admission in first counseling and those candidates who took admission during 1<sup>st</sup> counseling and desirous of change in discipline for 5 (five) vacant seats in respective categories are instructed to attend the second counseling to be held on **15.04.2021 at 10.00 A.M.**
- Those qualified candidates who could not get admission during 1<sup>st</sup> counseling and belonging to respective categories of vacant seats can also appear for second counseling.
- Further the qualified candidates of other categories also can appear for second counseling for consequential vacancies if any by way of conversion of vacant seats / sliding.
- However, change of colleges in respect of already admitted candidates in same discipline shall not be considered.
- Those candidates who are given admission during first counseling and did not join are not eligible to appear for second counseling.
- Those candidates who already exercised sliding option during 1<sup>st</sup> counseling are not eligible for second counseling.
- Those qualified candidates who were absent during first counseling are not eligible for second counseling.
- The 5 (five) vacant seats and consequential vacancies if any are college specific, hence change of institutions shall not be considered.

G.O RT No. 159 Higher Education (EC) Department, Dated: 13.11.2020 shall be followed in respect of seats vacated by meritorious reserved candidates.
